Wishing to participate in the above-identified event on the date(s) identified as described herein (collectively, the “Event”), and in consideration of Wizards of the Coast LLC’s (“Wizards”) agreement to allow me to participate in the Event, I agree to the following terms and conditions.

1. I will comply with all rules, regulations, and behavior standards applicable to the Event, as may be modified from time to time in Wizards’ sole discretion. I understand and agree that all decisions of Wizards and its authorized representatives, independent tournament organizers, and judges with respect to the Event are final.

2. I am legally competent to sign this Consent and Release Agreement or my parent or guardian has also read and signed this Release.

3. I agree that Wizards, its parent, subsidiaries, affiliates and related companies, sponsors/exhibitors of the Event, Wizards assigns, licensees, and independent tournament organizers may photograph me and record my voice and likeness, and may distribute, exhibit, broadcast, exploit, advertise, publicize, promote, and use my name, biographical material, likeness, voice, and performance in and in connection with the Event, other Wizards-sponsored events, products manufactured or licensed by or on behalf of Wizards, and in connection with advertising to promote the aforementioned events or products. I further agree that Wizards may edit my appearance therein and I waive any personal or proprietary rights with respect thereto. I represent and warrant to Wizards that I have not made any contract or commitment in conflict with this grant, and that I will seek no further consideration for any use contemplated by this Section 3.

4. I further agree that Wizards, its parent, subsidiaries, affiliates and related companies, sponsors/exhibitors of the Event, Wizards assigns, licensees, and independent tournament organizers may display my name, city, Event record and Event pairings online through websites and social media services to facilitate the Event as well as to display the Event’s record. I expressly consent to the public display of my aforementioned information

5. Wizards may, in its discretion, invite me to participate in its organized play programs. I agree to adhere to all program rules, conditions, and award requirements, as may be modified by Wizards from time to time in its sole discretion. Wizards reserves the right to terminate any organized play program (e.g., the Pro Tour Players’ Club program), or my participation in such program, at any time and for any reason in its sole discretion.

6. My participation in the Event may result in my receipt of an award by Wizards which may include, without limitation, cash or travel. Wizards reserves the right to

modify any and all prize or award structures associated with the Event, and to substitute any prize or award for another prize or award in its sole discretion. The following limitations shall apply to any award received by me as a result of my participation in the Event:

a. General. All awards are non-transferable, non-negotiable, and not redeemable for an alternative award except in Wizards’ sole discretion. All expenses not specified herein are my responsibility. Except as specifically stated herein, all taxes are my responsibility, and I acknowledge Wizards’ recommendation that I consult a tax advisor in my jurisdiction.

b. Cash award. Any cash awards will be distributed to me according to Wizards’ then-current standards for distribution.

c. Appearance Fee award. Any appearance fee I may receive will be distributed to me according to Wizards’ then-current standards for distribution. I understand and agree that I must attend and compete in the applicable tournament for which I am to receive the appearance fee, and failure to do so will disqualify me from eligibility to receive an appearance fee.

d. Airfare award. An airfare award shall consist of one (1) roundtrip coach air ticket, on an airline chosen by Wizards or its designate, from the major airport nearest my home to the city in which the applicable tournament or championship will be held. I will adhere to all instructions provided by Wizards to assist Wizards or its designate in booking such air ticket. Wizards or its designate will book such ticket to include the days of the applicable tournament or championship. Lodging, meals, gratuities, ground transportation, and fees caused by changes to airline reservations are my responsibility. Trip must be taken on dates designated by Wizards or award will be forfeited. Specific travel dates and arrangements are subject to availability.

e. Hotel Room award. This benefit begins thirty (30) days after a player has obtained a level that includes this benefit. Hotel room award shall consist of one (1) single-occupancy standard hotel room at a hotel chosen by Wizards or its designate for the dates of the applicable tournament or championship. I will adhere to all instructions provided by Wizards to assist Wizards or its designate in booking such hotel room. Wizards or its designate will book such hotel room to include the days of the applicable tournament or championship. Booking will include paid room and room tax only. Meals, gratuities, ground transportation, and fees caused by changes to hotel reservations are my responsibility. Room must be occupied me on dates designated by Wizards or award will be

forfeited. Specific dates and arrangements are subject to availability.

7. I AGREE TO RELEASE, INDEMNIFY, AND HOLD WIZARDS, ITS PARENT, SUBSIDIARIES, AFFILIATES AND RELATED COMPANIES, ANY OTHER SPONSORS/PROVIDERS, AND (IF APPLICABLE) THE TOURNAMENT ORGANIZER, AND THE DIRECTORS, OFFICERS EMPLOYEES, AGENTS, AND CONTRACTORS OF EACH HARMLESS FROM ANY AND ALL LOSS, INJURY, DAMAGE, CLAIM, AND/OR ACTION OF ANY KIND IN CONNECTION WITH THE EVENT (INCLUDING WITHOUT LIMITATION, JUDGING DECISIONS) OR ANY AWARD INCLUDING, WITHOUT LIMITATION, PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR CLAIMS BASED ON PUBLICITY RIGHTS, DEFAMATION, OR INVASION OF PRIVACY, WHETHER SUFFERED BY ME OR A THIRD PARTY, HOWEVER CAUSED, AND WHETHER FORESEEN OR UNFORESEEN. WIZARDS, ITS PARENT, SUBSIDIARIES, AFFILIATES AND RELATED COMPANIES, ANY OTHER SPONSORS/PROVIDERS, AND (IF APPLICABLE) THE TOURNAMENT ORGANIZER, AND THE DIRECTORS, OFFICERS EMPLOYEES, AGENTS,

AND CONTRACTORS OF EACH ARE NOT RESPONSIBLE FOR INJURY OR DAMAGE OF ANY KIND RELATED TO OR RESULTING FROM PARTICIPATION IN THE EVENT.

8. Nothing herein contained shall obligate Wizards to exercise any of the rights granted to Wizards herein.

9. The terms of this Consent and Release Agreement shall serve as a release and assumption of risk for my heirs, executor, administrator, and all members of my family, including any minors accompanying me. I understand this is a binding contract that supersedes any other agreements or representations, and is intended to provide a comprehensive release of liability but is not intended to assert any defenses which are prohibited by law. The specific rights of the parties may vary from state to state.

10. This Consent and Release Agreement shall be constructed and controlled by the laws of the State of Washington, USA. Any dispute under this Agreement shall be submitted to arbitration with Judicial Dispute Resolution LLC in Seattle, Washington USA. The arbitrator shall have authority to award reasonable attorneys fees and costs incurred to the substantially prevailing party.
